Of Thursday Dinners

Intellectual **Thursday** Dinners constitute a specific form of continuous self-education. The meetings are held by CEESTAHC www.ceestahc.org. The participants take turns to prepare lectures and workshops on specific subjects related to Evidence-Based Health Care, reimbursement, pricing, assessment of non-drug health technologies, pharmacoeconomics, methodology of financial analyses and specific organisational solutions in health care.

The scope of Dinners includes:

- analytical issues (EBM, HTA, BIA),
- problems related to EBHC and reimbursement and pricing policy,
- health insurance.

The participants are persons invited by CEESTAHC. Common Thursday dinners are organised nearly **each Thursday** from 16:00 till 18:00 in Krakow, in the CEESTAHC headquarters in Starowiślna Street 8/2.

Special Thursday Dinners are organised several times each year as a form of a summary of a few months of activity. During Special Thursday Dinners the presentations considered most interesting on common dinners are delivered, along with the lectures of 2-3 invited „external” experts. Apart from registered participants of common dinners, in Special Thursday Dinners persons invited by CEESTAHC may also take part. Certain Special Thursday Dinners are organised in cooperation with other institutions.

The name refers to „**Thursday dinners**” organised by the last **King of Poland, Stanisław August Poniatowski**. Those were intellectual meetings after the manner of Parisian literary salons. In the years 1770-77 the meetings were held regularly on Thursdays in the Royal Castle in Warsaw, and in summer in the Łazienki Palace. On meetings subjects related to art and science were discussed.

All lectures are planned in Polish (although exceptions are possible, since most participants speak English). After each presentation there is time for questions and answers. A break of 30 minutes is planned halfway in the meeting. The time of conclusion of the Special Thursday Dinner is approximate as the presentations or discussions may take longer than planned.
